



AdvCTC Free Tax Prep Days

This year, advance payments of the 2021 Child Tax Credit (CTC) will be made monthly from July through December to eligible taxpayers. To receive the payments, families must file a 2020 tax return.

The IRS will host AdvCTC Free Tax Prep Days, CTC outreach events taking place in 12 select cities. IRS **Taxpayer Assistance Centers** (TAC), key community stakeholders and volunteers will help eligible families prepare and file tax returns.

The American Rescue Plan Act of 2021 expands the CTC for tax year 2021

- The credit amounts will increase for many taxpayers.
- The credit for qualifying children is fully refundable, which means that taxpayers can benefit from the credit even if they don't have earned income or don't owe any income taxes.
- Taxpayers may receive part of their credit in 2021 before filing their 2021 tax return.
